In S.T.R.I.D.E. enhances the individual's quality of life by assisting them with improving their ability to work, go to school, live independently and have enjoyable relationships.

- Assessment and evaluation,
- Individual and family therapy
- Group therapy, including education and Wellness Recovery Action Plan (WRAP) groups,
- Psychiatric services,
- Case management,
- Vocational services,
- Crisis intervention,
- Skills building.
