Counselors provide phone screening and face-to-face assessment, intervention, and support so that youths may continue with life as planned. Services are provided by National Counseling Group. Spanish language services are available.

Crisis assistance is available every day, 24 hours per day by calling:

Services include:

- Rapid mobile response for youths age 17 and younger;
- Prevents unnecessary hospitalizations and placements outside the home;

- 24-hour intervention;
- Screening and triage;
- Clinical assessments, including lethality;
- Psychiatric assessment and services;
- Medication prescription;
- Bilingual counselors;
- Case management;
- 30-day post discharge support;
- Care coordination with community resources and professionals;
- Safety planning.
